I understand that if I accept employment with Garfield County Fire District 1, I may receive District owned property to fulfill my employment obligations. At the time my employment with the District ends, I shall promptly return to the District all of its property in good working condition. If I fail to do this, I will be held personally liable for any missing property.

I understand that the position for which I am applying may include driving fire and/or EMS apparatus, and includes work with individuals or groups who are recognized as vulnerable populations (i.e. the elderly, disabled, or children). Therefore, I give consent to a driving record, criminal history search, medical examination, and drug screening prior to employment if requested by the District.

I hereby understand and acknowledge that my employment relationship with this organization is of an "at will" nature, which means the District may discharge me at any time, with or without cause. It is further understood that this "at will" employment relationship may not be changed by any written document or by conduct unless such change is specifically acknowledged in writing by an authorized executive of this organization.

I certify that my answers on this form and on any attachments are true and complete to the best of my knowledge.

I am aware that if a search or investigation discloses misrepresentation or falsification, my application may be rejected, my name removed from the applicant list, and if already employed, may result in immediate termination.
